**WAIVER AND GENERAL RELEASE OF CLAIMS**

I understand that my participation in the Laguna Madre Tournaments Events (the "Events") involves a risk of personal injury to others and myself. I understand and agree that the Events in which participants will be engaged in the activity of fishing from various size watercrafts, either individually or in groups, throughout the tournament dates. I am voluntarily participating in the Events with knowledge of the risks involved, both bodily injury and/or water vessel damage, and hereby assume and accept any and all risks of injury to me and accept full responsibility for any and all injuries, damages or claims from any other person that may result from my participation. I further understand that the Event may be conducted during a period of foul weather or during a period when foul weather may suddenly manifest itself. The Releasees will not determine the appropriateness of weather conditions nor the suitability or sea worthiness of any vessel participating in the Event and leaves it to the discretion of each participant to determine the risk associated with participating in the Event or continuing to participate in the Event once the Event has begun.

I understand and agree that by signing this Waiver and General Release of Claims and Covenant Not to Sue I am releasing and discharging the sponsor of the Event, AutoNation Inc., and the specific AutoNation Dealership(s) that are involved in the Event in various capacities, and their respective directors, employees, trustees and any and all of its respective sponsors, donors, or affiliates (the "Releasees"), from any and all claims, demands, or causes of action that hereinafter may accrue against them and that in any way arise as a result of my participation in the Event.

I have read this Waiver and General Release of Claims and Covenant Not to Sue carefully and fully understand its contents. I AM AWARE THAT THIS IS AN AGREEMENT NOT TO SUE THE RELEASEES AND CONSTITUTES A COMPLETE RELEASE OF LIABILITY BY ME IN FAVOR OF THE RELEASEES. I acknowledge that I am eighteen (18) years of age or older, am signing this document of my own free will, and with full knowledge of the risks and responsibilities that I am assuming. If any minors are participating in the Event with me, I hereby execute this Waiver and General Release of Claims and Covenant Not to Sue on their behalf.

I hereby grant the sponsor of the Event and any and all of their respective subsidiaries or affiliates (the "Promoters"), the right to use my name and likeness, without any compensation, in whatever manner the Promoters in their sole discretion deem appropriate, and I hereby agree to cooperate fully with the Promoters in such activities.

Finally, I acknowledge that I am signing this Waiver and General Release of Claims and Covenant Not to Sue in consideration of the sponsor allowing me to participate in the Event.
